AN ORDINANCE
The Board of Supervisors of the County of Milwaukee does ordain as

SECTION 1. Section 99.01 of the General Ordinances of Milwaukee

General Ordinances of Milwaukee County is amended as follows:

It is the policy of the county board to assure the safety and well-being of all the citizens of the county in the event of an emergency arising out of a natural or Civil disaster or an enemy action. To advance this policy, it is hereby declared necessary that an effective county emergency management program be established and maintained in the county at all times. The office of the county executive shall discharge the county a secutive shall discharge the responsibilities imposed by this chapter investict conformity with and in no instance shall exceed the authority delegated to the county in ch. 166323, Wis. Stats. SECTION 2. Section 99.02 of the

General Ordinances of Milwaukee County is amended as follows:

(1) In accordance with 166.03(4)(b)s. 323.14(1)(a)2. Wis. Stats., the county executive chall

hereby designate the hereby designated as the county emergency management director. In addition to the duties herein set forth, the sheriff county executive shall coordinate and direct, all administrative and management functions of the county emergency management program in accordance

with e. 59.031ch. 323, Wis. Stats. (2) Duties of the county emergency management director.

(a) The county emergency management director shall perform all the duties enumerated in ch. 166323, Wis. Stats

(3) The cheriff county executive may appoint a county head of emergency management services who shall administer the county emergency management organ-

ization. (4) The head of emergency management service shall execute his/her duties in accordance with ch. 323co. 166.03(4) and 166.03(5)(a) through (d), Wis. Stats.

SECTION 3. The provisions of this ordinance shall be effective upon passage and publication. Adopted by the Milwaukee County.
