## **BACKGROUND**

An update to Milwaukee County's Park and Open Space Plan (aka 2050 Plan) has been in development for several years. Primary topics of the plan include:

- Chapter 1 Introduction, system history, plan purpose, and project methodology including approval.
- Chapter 2 Information about the County pertinent to park and open space planning, including information on the existing resident population, land use patterns, and natural resource base of the County.
- Chapter 3 Information on existing park sites and facilities and open space lands within the County.
- Chapter 4 A framework for plan development, including summaries of existing reports and public input opportunities that may influence the development of the plan

- Chapter 5 Level of service information; preservation, acquisition, and development objectives, principles, and standards; and an analysis of the County's park and open space needs
- Chapter 6 A recommended park and open space plan that identifies the actions required to carry out the recommended plan.
