 - B. The 2022 Adopted Budget includes funding for this contract. The revenue from the event based on a three-year average (2017-2019) totals over \$1.3M annually and more than covers the cost of this contract.
 - C. Due to the pandemic, Milwaukee a la Carte was cancelled in 2020 and 2021. It is anticipated that the event will be held in 2022.
