Consisting of nine (9) board members, to include two Milwaukee County Board of Supervisors, which shall constitute the board of directors, Milwaukee County Code of General Ordinance 93.02. I am hereby appointing Ms. Priscilla Coggs-Jones to serve on the Combined Community Service Board (CCSB) in the capacity of 1 of 2 Milwaukee County Board of Supervisors.
