Subject:	From the Executive Director of Parks asking for passive review of a third amended scope of work with Cardno Inc. for engineering services, final design and development, and an archeological review of the Little Menomonee River and Parkway which causes the agreement to exceed \$100,000

REQUEST

The Executive Director of Parks is requesting passive review of a professional service agreement with Cardno, Inc. due to a change in scope that requires a fee revision over \$100,000. The original contract was for engineering services and final design development for Little Menomonee River Parkway and the change of scope includes an archaeological assessment of the LMR Corridor.

POLICY

Implementation of Wisconsin Statutes 59.21(31) with regard to purchase of professional service agreements (under the Milwaukee General ordinance Chapter 56) requires County Board review to award the initial agreement, or fee extension(s) to the original agreement, when the total contractual fee exceeds \$100,000 but is less than \$300,000.

BACKGROUND

In January of 2021 Parks contracted with Cardno, Inc. to complete a habitat management plan and wetland scrape design for the project area known as Sections 4 & 5 of Little Menomonee River Parkway (LMR Parkway), as part of the grant agreement with the Wisconsin Department of Natural Resources.

In the prior Amended Work Scope #1 that was approved by Milwaukee County on March 18, 2021, Cardno was contracted to conduct an archaeological archival/literature review of Little Menominee River Sections 2 - 6. This review is being done to identify cultural resources

immediately adjacent to the project area which may be impacted by future projects, to provide context for the resources within the project area, and to determine the likelihood for unidentified resources along the Little Menomonee River corridor. Field visits to support the archival/literature review were not requested by Milwaukee County and were not included within Amended Work Scope #1.

In the prior Amended Work Scope #2, Cardno was requested to conduct on-site field checks (visual inspection, photo documentation, etc.) of the Little Menominee River Section 2-6 consisting of roughly 5.5 miles and approximately 650 acres as requested by the Wisconsin Department of Natural Resources (WDNR). This was requested to support the desktop review of archival/literature resources in order to meet the requirements of Section 106 of the National Historic Preservation Act of 1966 (NHPA)

Additional effort was required in order meet the requirements of NHPA Section 106 including:

- Number of architectural resources that needed investigations/evaluation (108 previously recorded historic resources, several unrecorded subdivisions with potentially eligible resources, several historic districts/possible historic districts).
- Additional review of historic plats and aerial images necessary to understand the history of land use in the vicinity of the LMR Parkway. This was needed to understand the potential for unrecorded resources and assist with future planning needed under the state and federal regulations in discussion with WDNR.
- Additional GIS support and edits for figures and report as requested from WDNR.
- Additional NHPA Section 106 requirement requests from Milwaukee County and WDNR. This support was included in the Archaeological and Architectural Assessment Planning Document that was completed as outlined in Amended Work Scope #1 and #2.

Due to the additional work, it is necessary to have a third amendment and fee revision to the contract. This increases the contract from \$113,694 to \$119,338, an increase of \$5,644.

before a final decision is made. This process is an important tool for citizens to lend their voice in protecting and maintaining historic properties in their communities. This work ensures the protection of culturally significant resources and ensures diverse communities are not marginalized. The use of grant money for this work ensures the fiscal health and sustainability of the County.

Sufficient funds are budgeted because this contract is being paid by grant funding.
