

Overall Sentiment







Calling for more crack downs upon people assembling to levy their concerns against an unaccountable government is precisely what our federal constitution is supposed to protect. To limit the right to publicly assemble in the face of obscene state violence is nothing more than a means to further repress a community with sincere concerns about the way their government operates. This will be yet one more example of how our government demonstrates overt biases against the general public by routinely choosing to penalize the public while simultaneously protecting abuses within its own systems, institutions, and ranks in the same stroke. If the local government was interested in public safety and health it would be calling for more accountability and transparency from actors its legal institutions rather than trying to penalize people with gripes against it.
