## **REQUEST**

The Milwaukee County Board requested an informational report on the acquisition and disbursal of fentanyl test strips by DHHS Behavioral Health Services (BHS).

## **POLICY**

Senate Bill 600

# **BACKGROUND**

The State Legislature passed Senate Bill 600 and now awaits the Governor's signature. The bill decriminalizes the use of fentanyl testing strips. Previously under State law, fentanyl test strips were considered drug paraphernalia making it a felony to use or possess them. The legislation, led by Sup. Sylvia Ortiz-Velez was critical due to the following devastating realities:

- Fentanyl is present in the vast majority of deaths from drug overdose. In 2020, 400 of the 544 overdose deaths in Milwaukee County involved fentanyl. In 2021, the number is expected to be three times the homicide rate (toxicology reports still pending).
- Fentanyl is 50-100 times more powerful than morphine. A prescription opioid, it is often mixed into street drugs including cocaine, methamphetamine, MDMA or formed into pills to resemble oxycodone.
- Given its potency as a synthetic opioid, between 2015 and 2020, the number of overdose deaths involving fentanyl in Milwaukee County rose rapidly from 8% to 73%.
- The only way to know if fentanyl is present is to use a testing strip, which provides 100% accuracy for approx. \$1 per strip. However, use of these strips is a felony. Individuals with substance abuse disorders should be able to test for fentanyl to avoid exposure.
- First responders including EMTs, and law enforcement professionals would be better equipped to manage overdose crisis situations as well as better protect themselves from exposure if

• able to utilize testing strips.

Behavioral Health Services, in collaboration with the Milwaukee Health Department, have an immediate supply of fentanyl testing strips to be distributed as soon as the Governor signs the bill into law. The State Department of Health Services has a plan to ensure a sustainable supply of test strips to Milwaukee County, and BHS will distribute these to Access Points and other logical community-based partners. A press release (attached) has been prepared to make the public aware of this important step forward in reducing overdose deaths in the Milwaukee community.
