  - A. The Milwaukee County Zoo requests authorization to enter into a contract with Immotion for a virtual reality (VR) theater that combines educational VR experiences with state-of-the-art motion-platform technology for an immersive edutainment experience that will engage visitors and increase revenues for the Zoo. This is a 50%/50% revenue share contract.
  - B. The 2022 Budget included a 4D Theater revenue share contract with expenditures of \$278,2134 (contract payment of \$239,100) and revenues of \$359,840 for a net profit of \$81,627. With the change to a VR theater, the Zoo's proforma projects revenues of \$641,504 (\$320,752 contract payment) and expenditures of \$405,859 for a net profit of \$235,645. The variance between the 4D theater versus the VR theater is an increase to the budget of \$281,664 in revenues, \$127,646 in expenditures for a profit increase of \$154,018.

There are no capital expenditures for this as the cost of installation and equipment is the vendor's responsibility. The Zoo will be responsible for daily ticket sales and operating the exhibit.

C. Based on the Zoo's projections, revenues of \$281,664 and expenditures of \$127,646 will exceed the allocation included in the 2022 Operating Budget. When this occurs, the Zoo will submit a fund transfer for the Comptroller's Office in conjunction with the Office of Strategy, Budget, and Performance (SBP) to recognize the revenues and expenditures as needed for the operation of the theater.

Future budgets will reflect the revenues and expenditures from operation of the VR Theater.

D. The Zoo's proforma was based on prior years attendance and a guest penetration rate of 12%. The 12% penetration rate is in line with actual penetration rates from prior exhibits in the Special Exhibit building. The admission fee used for this calculation is based on a \$6.50 average fee.

The Zoo will seek sponsor for this exhibit, which will generate \$25,000 to \$30,000 annually and will be included in the 2023 Budget.
