

From the Director, Department of Transportation, requesting authorization to amend Chapter 69 Section 69.02 of the General Ordinances to add a No Parking on West Rawson Avenue (CTH BB) from South 27<sup>th</sup> Street to South Howell Avenue, by recommending adoption of the following:

**A RESOLUTION/ORDINANCE**

WHEREAS, Section 69.02 of the Milwaukee County Code of General Ordinances (the Code) establishes parking regulations on Milwaukee County (the County) highways, pursuant to the authority established by Section 349.13, Wisconsin State Statutes; and

WHEREAS, the Transportation Services Division, Department of Transportation, determined during the reconstruction project of West Rawson Avenue (County Trunk Highway [CTH] BB), that there was a No Parking Zone that was not in the Code; and

WHEREAS, South 20<sup>th</sup> Street to South 13<sup>th</sup> Street was reconstructed by the State of Wisconsin Department of Transportation, with the Interstate 41/94 North/South Project, where all sections will have bicycle accommodations; and

WHEREAS, removing the parking restriction on West Rawson Avenue - CTH BB would allow vehicles to park within the bicycle accommodation, causing unsafe conditions; and

WHEREAS, it has been determined to keep the existing no parking restrictions along West Rawson Avenue - CTH BB, from South 27<sup>th</sup> Street to South Howell Avenue, by modifying the Code; and

WHEREAS, the Committee on Transportation, Public Works, and Transit, at its meeting of March 9, 2022, recommended adoption of File No. 22-378 (vote 4-0); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby amends Section 69.02 of the Milwaukee County Code of General Ordinances, by adopting the following:

41 The County Board of Supervisors of the County of Milwaukee does ordain as  
42 follows:

44 **SECTION 1.** Chapter 69 of the Milwaukee County Code of General Ordinances is  
45 hereby amended as follows:

46  
47 **Section 69.02. – Parking prohibited in designated areas.**

48  
49 No person shall stop or leave any vehicle standing in any of the following places,  
50 except temporarily, for the purpose of and while actually engaged in loading or  
51 unloading or in receiving or discharging passengers and while the vehicle is attended by  
52 a licensed operator:

53 (1) College Avenue (C.T.H. 'ZZ')

54 (a) Between the limits of South 20th Street and South 27th Street.

55 (b) On the south side, from a point four hundred fifty (450) feet east of  
56 South 35th Street to the limits of South 27th Street.

57 (2) South 76th Street (C.T.H. 'U')

58 (a) Between the limits of West Grange Avenue and West Layton Avenue.

59 (b) Between the limits of West Ryan Road and a point three-fourths ( $\frac{3}{4}$ ) of  
60 a mile north of Ryan Road.

61 (c) Along the west side of South 76th Street (C.T.H. U) from a point six  
62 hundred fifty (650) feet south of the south line of West Ryan Road to a  
63 point nine hundred seventy-five (975) feet south of the south line of  
64 West Ryan Road.

65 (d) Along the west side of South 76th Street (C.T.H. U) from a point one  
66 thousand seventy-five (1,075) feet south of the south line of West Ryan  
67 Road to a point one thousand two hundred (1,200) feet south of the  
68 south line of West Ryan Road.

69 (3) Good Hope Road (C.T.H. 'PP')

70 (a) Between the limits of North Port Washington Road and North Pierron  
71 Road.

72 (4) South 68th Street (C.T.H. 'A')

73 (a) Between the limits of West Ryan Road and a point three-fourths ( $\frac{3}{4}$ ) of  
74 a mile north of Ryan Road.

75 (5) West Beloit Road (C.T.H. 'T')

76 (a) North side of the road from the intersection of South 108th Street  
77 (S.T.H. 100) to a point five hundred seventy (570) feet east of South  
78 108th Street.

- 80 (6) West Layton Avenue (C.T.H. 'Y')
- 81 (a) From the limits of South 60th Street to a point eight hundred twenty-
- 82 five (825) feet east of South 60th Street.
- 83 (b) On the south side of the street from the limits of South 49th Street to
- 84 the limits of South 48th Street.
- 85 (7) South 92nd Street (C.T.H. 'N')
- 86 (a) On the west side of the street from the limits of West Howard Avenue
- 87 to the limits of West Waterford Avenue.
- 88 **(8) West Rawson Avenue (CTH 'BB').**
- 89 **(a) On both sides of the street from South 27<sup>th</sup> Street to South Howell**
- 90 **Avenue.**
