From the Director, Department of Transportation, requesting authorization to amend Chapter 69 Section 69.02 of the General Ordinances to add No Parking on West Beloit Road (CTH T) along the Root River Oak Leaf Trail Crosswalk east of West Howard Avenue, by recommending adoption of the following:

A RESOLUTION/ORDINANCE

WHEREAS, Section 69.02 of the Milwaukee County Code of General Ordinances (the Code) establishes parking regulations on Milwaukee County (the County) highways, pursuant to the authority established by Section 349.13, Wisconsin State Statutes; and

WHEREAS, there is a crosswalk on West Beloit Road (County Trunk Highway [CTH] T) for the Oak Leaf Trail (the Trail), between the Root River and West Howard Avenue; and

WHEREAS, the Transportation Services Division, Department of Transportation determined during the rehabilitation project of West Beloit Road - CTH T, vehicles frequently park in this section to access the section of Trail; and

WHEREAS, some Trail users park near the crosswalk to use the Trail, sometimes too close, impacting visibility of those crossing the crosswalk; and

WHEREAS, it has been determined during the rehabilitation of West Beloit Road - CTH T, that it would be in the best interest of safety to add a No Parking Zone along the Root River Oak Leaf Trail Crosswalk, east of West Howard Avenue; and

WHEREAS, the Committee on Transportation, Public Works, and Transit, at its meeting of March 9, 2022, recommended adoption of File No. 22-358 (vote 4-0); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby amends Section 69.02 of the Milwaukee County Code of General Ordinances, by adopting the following:

40 The County Board of Supervisors of the County of Milwaukee does ordain as
41 follows:

43 **SECTION 1.** Chapter 69 of the Milwaukee County Code of General Ordinances is
44 hereby amended as follows:

46 **Section 69.02. - Parking prohibited in designated areas.**

48 No person shall stop or leave any vehicle standing in any of the following places,
49 except temporarily, for the purpose of and while actually engaged in loading or
50 unloading or in receiving or discharging passengers and while the vehicle is attended by
51 a licensed operator:

- 52 (1) College Avenue (C.T.H. 'ZZ')
- 53 (a) Between the limits of South 20th Street and South 27th Street.
- 54 (b) On the south side, from a point four hundred fifty (450) feet east of
- 55 South 35th Street to the limits of South 27th Street.
- 56 (2) South 76th Street (C.T.H. 'U')
- 57 (a) Between the limits of West Grange Avenue and West Layton Avenue.
- 58 (b) Between the limits of West Ryan Road and a point three-fourths (¾) of
- 59 a mile north of Ryan Road.
- 60 (c) Along the west side of South 76th Street (C.T.H. U) from a point six
- 61 hundred fifty (650) feet south of the south line of West Ryan Road to a
- 62 point nine hundred seventy-five (975) feet south of the south line of
- 63 West Ryan Road.
- 64 (d) Along the west side of South 76th Street (C.T.H. U) from a point one
- 65 thousand seventy-five (1,075) feet south of the south line of West Ryan
- 66 Road to a point one thousand two hundred (1,200) feet south of the
- 67 south line of West Ryan Road.
- 68 (3) Good Hope Road (C.T.H. 'PP')
- 69 (a) Between the limits of North Port Washington Road and North Pierron
- 70 Road.
- 71 (4) South 68th Street (C.T.H. 'A')
- 72 (a) Between the limits of West Ryan Road and a point three-fourths (¾) of
- 73 a mile north of Ryan Road.
- 74 (5) West Beloit Road (C.T.H. 'T')
- 75 (a) North side of the road from the intersection of South 108th Street
- 76 (S.T.H. 100) to a point five hundred seventy (570) feet east of South
- 77 108th Street.
- 78 **(b) On both sides of the street from 100 feet east to 100 feet west of**
- 79 **the Root River Oak Leaf Trail Crosswalk east of West Howard**
- 80 **Avenue.**
- 81

- 82 (6) West Layton Avenue (C.T.H. 'Y')
- 83 (a) From the limits of South 60th Street to a point eight hundred twenty-
- 84 five (825) feet east of South 60th Street.
- 85 (b) On the south side of the street from the limits of South 49th Street to
- 86 the limits of South 48th Street.
- 87 (7) South 92nd Street (C.T.H. 'N')
- 88 (a) On the west side of the street from the limits of West Howard Avenue
- 89 to the limits of West Waterford Avenue.

91 **SECTION 2.** The provisions of this Ordinance shall become effective upon passage and
92 publication.
