WHEREAS, the State subsequently agreed to provide American Rescue Plan Act (ARPA) operating assistance to the County, in the amount of \$19,797,794, to partially offset the reduction in Section 85.20 funding; and

WHEREAS, the County's 2022 Adopted Capital Budget includes Capital Project WT0152, for the purchase of 60 clean-diesel buses, funded with \$25.44 million from various Federal grants, and \$6.36 million from State ARPA funds, to cover the required 20 percent local share; and

WHEREAS, the Department of Transportation has been advised that State ARPA funding may only be used for operating expenditures; and

WHEREAS, there is currently no funding or expenditure authority for the required (Federal) inspections in Capital Project WT0152, and the per-bus cost is slightly higher than estimated; and
