BACKGROUND

Resolution 22-120 requests the Department of Parks, Recreation and Culture to implement a countywide 50/50 raffle which shall occur at County Park beer gardens and the 2022 lakefront fireworks show.

Milwaukee County Parks will partner with the independent non-profit Milwaukee Parks Foundation to implement a pilot 50/50 raffle program in 2022. The Parks Foundation will manage the logistics of the raffle and will develop a plan to fund park improvements depending on the success of the pilot.

In order to conduct a raffle in the State of Wisconsin, the organizer must have a permit that is issued by the State's Department of Administration. This application can take over 6 weeks for approval which means that any raffle event before June may not be feasible depending on the timing of the approval of this plan.

Most County Park events are run by nonprofit organizations who need to do their own fundraising (i.e., the Eastown Association runs Jazz in the Park, the Friends of Lake Park host Music in the Park). These groups are also likely doing their own fundraising at these events, and Parks will need to be intentional about how we partner with them to ensure a collaborative approach.

The following revenue estimate was prepared by the Parks Foundation.

Estimated Revenue

- \$2,500 RAISED AT JUNE JAZZ IN THE PARK (Estimated attendance of 5,000 people, approximately 10% ticket sales)
- \$25,000 RAISED AT JULY 3 FIREWORKS (Estimated attendance of 100,000 people, approximately 5% ticket sales)
- \$1,000 RAISED AUGUST LAKE PARK MUSIC: Estimated attendance of 2000 people, 10% ticket sales
- Total Max. Revenue from Pilot: \$28,500

Estimated Expenses

Supplies: \$500

• Advertisements and signage: \$500

Staff Cost: 60 hours at \$30/hour: \$1,800

Total Expenses for Pilot: \$2,800
