## KEY FINDINGS

For the reporting period of January through March 2022, total contract dollars awarded was approximately \$179,377,488.

Of that amount, \$17,535,190 was eligible for DBE/TBE participation.

Contracts held by DBE/TBE companies was approximately \$9,548,310 or 54.5% of eligible contract dollars and 5.3% of total contract dollars awarded.
