From the Chief Deputy, Office of the Sheriff, requesting retroactive authorization to enter into an Agreement with Froedtert Memorial Lutheran Hospital Inc. (FMLH) to provide law enforcement related services on the premises of FMLH emergency department in an estimated amount for the first contract year of \$1,100,950 from April 1, 2022, to March 31, 2023.], by recommending adoption of the following:

A RESOLUTION

WHEREAS, the Office of the Sheriff (Sheriff) is requesting retroactive authorization to enter into an Agreement with the Froedtert Memorial Lutheran Hospital (FMLH), Inc., Emergency Department for the purpose of providing law enforcement-related services, including but not limited to, uniformed security services, marked squad operations, critical incident response, and investigations for the period beginning April 1, 2022, and ending midnight on March 31, 2023; and

WHEREAS, this Agreement shall automatically continue in full force and effect from year-to-year, under the terms and conditions provided herein, unless terminated by either party upon 90-days prior written notice; and

WHEREAS, the Sheriff shall station two Deputy Sheriffs to perform law enforcement services during all three shifts, 24-hours per-day, 365 days of the year, on or about the premises of FMLH, with the primary location being the FMLH Emergency Department; and

WHEREAS, the rates per-hour have been approved by the Sheriff’s Fiscal Administration, and agreed upon by FMLH, but are subject to change per Milwaukee County’s contracts with the Milwaukee Deputy Sheriff’s Association, and the budgets for each fiscal year; and

WHEREAS, the current rates are as follows:

WHEREAS, the Deputy Sheriffs will be subject to, and shall abide by, all the Sheriff's rules and regulations, as well as complying with all local, State, and Federal laws; and

WHEREAS, Section 59.52(31)(c), Wisconsin State Statutes, requires the Milwaukee County Board of Supervisors to authorize a contract for services with a value greater than \$300,000; and

WHEREAS, the Committee on Finance, at its meeting of May 19, 2022, recommended adoption of File No. 22-487 (vote 6-1); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby authorizes the Chief Deputy, Office of the Sheriff, to retroactively enter into an Agreement with Froedtert Memorial Lutheran Hospital (FMLH), Inc., to station two, uniformed Deputy Sheriffs on or about the premises of the FMLH Emergency Department, in a total estimated first contract year amount of \$1,100,950 during all three shifts, 24-hours per-day, 365 days of the year, for the period beginning April 1, 2022, and ending midnight on March 31, 2023, with the Agreement then continuing in full force and effect from year-to-year, unless terminated by either party upon written notice of 90 days.
