

Overall Sentiment









This report is nonsense. It is packed with helpless complacency and bizarre detailing of an entirely ineffective advertising campaign. The report details that only 6% percent of aquatics seasonal positions had been filled as of April. The report states, "Every year the number of returning and new recruits for seasonal positions is less than the year before..." but does not analyze whether current pay rates are competitive or why the jobs remain unfilled. Supply and demand clearly indicates that if the positions are harder to fill year after year, we are not offering enough money to make these jobs attractive to applicants.

The County has recently announced that it will not be able to open the majority of deep water pools due to the lack of lifeguards. It is also closing the majority of wading pools and even splash pads due to lack of seasonal staff. The current job listing posted (Park Worker I: Under general supervision, to monitor and assist at wading pools and Park Worker III: Under general supervision, to operate and maintain park wading pools) makes it very clear why these positions were only 6% staffed, when it specifies: Min Hiring Rate \$9.11 - Max Hiring Rate \$12.19. This is not even close to an attractive wage rate for these positions.

Furthermore, the report states that the Parks Department is working closely with high schools and guidance counselors to try to fill these positions. This is not happening effectively. My son is a three-season athlete (including varsity swimming) at Rufus King, and neither he nor any of his teammates in any sport or classmates in any class have been notified, approached, or recruited in any way to apply for summer positions with the County Parks. Our community is full of youth seeking well-compensated employment for the summer. Unfortunately, the

County is not offering good wages, nor is it directly reaching the intended audience with its recruiting campaign.

The report claims that a recruiting campaign has made more than 3 million "impressions," but the entire population of Milwaukee County doesn't even begin to approach that number of people, much less the number of teens. If the advertisements aren't being directed to Milwaukee County teens, what are we even doing with this advertising budget? Large, unattractive billboards are not going to drive teen job applications. A clickable approach is needed.

The County should be asking high school teachers, coaches, and administrators to post these opportunities directly to students, and it should be paying a reasonable wage (\$12-\$15 for parks attendants, \$17-\$22 for lifeguards).

It is vital that the County hire local teens to staff these positions. We need our youth productively employed in prosocial pursuits while school is out, and we need safe recreational spaces for youth and family to cool off in the summer heat. When our community lacks these basics, violence increases and health and safety for all are jeopardized.

Please act with urgency to increase these pay rates and have the parks post the increased pay and job application links directly on official social media accounts (not random advertising and billboards) so that they can be shared widely by community members, teachers, and coaches. We can, and must, get our vital public infrastructure appropriately staffed for summer!
