Informational report on the proposed dock improvement project at Milwaukee Yacht Club

BACKGROUND

The Milwaukee Yacht Club has been in operation since 1871, and recognized since then as entitled to special privileges under 46 USCA, Section 105, as an organization aiding navigation. The land has been leased to the Yacht Club by Milwaukee County since October 1966. Milwaukee County entered into a twenty-five-year lease with an additional twenty-five-year option via File 18-745.

The approved lease outlines processes for improvements to the premises including permanent improvements, alterations, or renovations. Milwaukee County Parks has engaged with Milwaukee Yacht Club to satisfy the requirements of the lease wherein detailed construction plans are submitted for review and approval.

The proposed improvements address multiple existing issues for Milwaukee Yacht Club. The docks at the Milwaukee Yacht Club are older than those at McKinley Marina and cannot accommodate the varying water levels of Lake Michigan. Replacing the docks also allows for improving the utility connections that run through the docks to service the boats. A new orientation for the docks is proposed to accommodate wider boats and improved circulation. Milwaukee Yacht Club has agreed to host a public meeting and accept public input regarding the proposed improvements.
