The contract continues existing financial terms, leaving all other terms unchanged, and extends the agreement through May 31, 2025. The proposal includes a market check provision for 2022. Regardless of the difference in terms, the financial impact of the change will be negligible.
- C.) There is no impact to the current year. All costs in subsequent years will be reflected in the org.1950 (non-departmental fringe benefits) budgets.
