REQUEST

The Executive Zoo Director of the Milwaukee County Zoological Gardens is requesting an extension of David Engelmann Temporary Assignment to a Higher Classification (TAHC) to the position of Mechanical Services Manager until the position is filled. The request is being made to maintain consistent leadership prior to the permanent filling of the Mechanical Services Manager position. Expected recruitment for the position is underway.

POLICY

Chapter 17.085 of the Milwaukee County Code of General Ordinances requires an extension of temporary assignment beyond 180 days be approved by the Milwaukee County Board of Supervisors.

BACKGROUND

The Mechanical Services Manager position became vacant in January of 2022. The Zoo will be recruiting for the position and expects to fill it permanently as soon as possible.
