 - A. DHHS is requesting ARPA funds to bolster Milwaukee County's housing assistance efforts during a time of immense need in the community.
 - B. Increased programming will increase expenditures by \$18,000,000, while allocation of ARPA funding will offset that expenditure in an equal amount of revenue.
 - C. Sufficient funds are available for this action through the allocation of ARPA revenue. These funds are one-time in nature and are being used in this resolution to address an acute issue. If the full \$18 million is not expended in 2022, the balance of funding will carry forward into 2023 and a fund transfer will be done to adjust the budget.
 - D. No assumptions or interpretations were made.
