REQUEST

The Chief Judge requests to create the following position:

1 FTE Court Coordinator-Mental Health Treatment Court, pay grade 29M.

BACKGROUND

Milwaukee County Combined Courts started a pilot Mental Health Treatment Court (MHTC) in 2014. The pilot court serves between 5 and 7 individuals at any given time. The court has been limited to a pilot due to not having dedicated staff; however, the need for a Mental Health Treatment Court remains present. It is estimated that in 2020, 26% of the population who went through Universal Screening were assessed as needing a further mental health assessment based on the Brief Jail Mental Health Screen¹.

In March of 2022, the Milwaukee Community Justice Council submitted a request for American Rescue Plan Act dollars to Governor Evers to help the courts address the backlog of cases due to the pandemic. Included in the request was funding for 1 FTE

¹ Universal Screening is an evidence-based program that operates 24/7/365 in the Criminal Justice Facility (CJF). The contracted provider conducts an assessment on all individuals booked into the CJF on a bailable charge(s) to determine pretrial risk. Universal Screening includes an interview to determine the needs of the individuals and possible early intervention eligibility. The Brief Jail Mental Health Screen (BJMHS) is included in the interview. It is a self-report mental health screen to help with early identification of severe mental illnesses and other acute psychiatric problems during the intake process.

Mental Health Treatment Court Coordinator.

The Mental Health Treatment Court Coordinator will provide the critical resource for the MHTC by ensuring coordination in the development, adherence to best practices/standards, accountability of stakeholders for the court. This dedicated FTE will help build the foundation and move the MHTC from a pilot court to an institutionalized therapeutic court in Milwaukee County.

FISCAL EFFECT

County Board resolution 22-476 authorized the Office of Strategy, Budget, and Performance to process appropriation transfers to recognize and increase revenues and expenditures by \$14,719,000 to Org Unit 2000 – Combined Court Related Operations, of which \$195,000 is for the Mental Health Treatment Court Coordinator. The position will be paid for by ARPA funding.
