





Dear Finance Committee Members,

As members of the Wauwatosa Joint Housing Coalition we request your approval of Finance Committee 6/16/22 agenda item 1 (file # 22-702) for \$18 million in ARPA funds for affordable housing opportunities in Milwaukee County. We are specifically interested in the \$15 million designated for "gap financing for projects that have

identified other sources of funding to be used as leverage..." with the main focus to "increase the supply of affordable housing in Milwaukee County's suburban municipalities..."

We are aware of several Wauwatosa projects in the development process which include affordable housing that could potentially benefit from such funds to either increase the number of affordable units and/or increase the number of units available at the 30% - 60% AMI range. We are keenly aware of the need for more affordable housing in our city, and how historic patterns of housing segregation have limited development of it in Wauwatosa and other Milwaukee County suburban municipalities.

The Wauwatosa Joint Housing Coalition has been working together for the last 18 months to increase affordable and accessible housing for low-income seniors, families, and persons with Disabilities in our city. Our group consists of the Wauwatosa Senior Commission, Wauwatosa Equity and Inclusion Commission, the Wauwatosa Commission for Persons with Disabilities, and the Tosa Together community group which works for equity and inclusion in the city. We have developed relationships with our city development staff and a number of developers and stand ready to assist in whatever way needed to promote and support affordable housing in Wauwatosa.
