From the American Rescue Plan Act (ARPA) Revenue Loss Recovery Subgroup requesting authorization of \$21,996,141 million in ARPA Funds for "Fiscal Health Challenge" project requests, which include one-time investments that provide long term cost savings, revenue enhancements, and/or operational efficiencies, by recommending adoption of the following:

AN AMENDED RESOLUTION

WHEREAS, the Federal American Rescue Plan Act (ARPA) of 2021 was signed into law by President Biden on March 11, 2021, in efforts to support individuals, families, businesses, and governments impacted by the Coronavirus Disease pandemic; and

WHEREAS, Milwaukee County (the County) will receive \$183.7 million in ARPA funding, through the ARPA State and Local Fiscal Recovery Fund (SLFRF); and

WHEREAS, the Milwaukee County Board of Supervisors adopted File No. 21-555: "A resolution to create a Task Force (ARPA Task Force) to review and recommend funding allocations to the Milwaukee County Board of Supervisors for monies received by the County in the Federal American Rescue Plan Act of 2021"; and

WHEREAS, of the County's \$183.7 million of ARPA aid, approximately \$115.7 million has been recommended by the ARPA Task Force for the Revenue Loss Recovery Subgroup, to generate project-level allocation recommendations to improve the fiscal health of the County, and strengthen support for vital services; and

WHEREAS, the Revenue Loss Recovery Subgroup created the Fiscal Health Challenge to improve the County's fiscal position through cost savings, revenue generation, and/or operational improvements; and

WHEREAS, Fiscal Health Challenge proposals are selected based on the Federal regulations for use of ARPA funds, as well as the criteria set forth by the ARPA Task Force on September 2, 2021; and

WHEREAS, the Revenue Loss Recovery Subgroup recommended Fiscal Health Challenge projects identified as high priority projects to the ARPA Task Force on April 14, 2022, and the ARPA Task Force recommended the high priority projects for ARPA funding (vote 5 Ayes and 1 Excused); and

WHEREAS, the Committee on Finance, at its meeting of May 19, 2022, recommended adoption of File No. 22-592 as amended (vote 7-0); and

WHEREAS, the Milwaukee County Board of Supervisors, at its meeting of May 26, 2022, referred File No. 22-592 to the Committee on Parks, Energy, and Environment (PE&E) (vote 10-7); and

WHEREAS, the Committee on PE&E, at its meeting of June 14, 2022, recommended adoption of File No. 22-592 as amended (vote 5-0); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors (County Board) authorizes \$21,996,141 in American Rescue Plan Act funding for Fiscal Health Challenge project recommendations, as outlined in the below chart and further described in the report attached to this file:

BE IT FURTHER RESOLVED, the County Board hereby authorizes the Office of Strategy, Budget, and Performance, and the Office of the Comptroller to process administrative appropriation transfers of \$21,996,141, to establish project and operational budgets for approved Fiscal Health Challenge projects; and

BE IT FURTHER RESOLVED, the County Board of Supervisors hereby authorizes the administrating department, the Office of Strategy, Budget and Performance, the Office of Corporation Counsel, the Department of Administrative Services, Risk Management Division, Community Business Development Partners, Comptroller, and County Executive, to prepare, review, approve, and execute all contracts and other documents, and take all actions as required for the purpose of administering the above-referenced Fiscal Health Challenge projects funded by the American Rescue Plan Act; and

BE IT FURTHER RESOLVED, the Office of Strategy, Budget and Performance, in collaboration with administering departments, shall provide an annual report including status updates related to the above-referenced Fiscal Health Challenge projects, with annual report updates to be provided throughout the duration of the American Rescue Plan Act grant timeline.
