

Overall Sentiment







P.A.G.E. (People Advocating for Greendale Equity) supports Milwaukee County Board Resolution 8-22-703 on racially restrictive covenants

Having recently advocated for a similar resolution that the Greendale Board of Trustees passed unanimously last

week, P.A.G.E. is delighted to hear that the Milwaukee County Board of Supervisors is considering a resolution denouncing racially restrictive covenants found in many housing deeds and other real estate documents in the County. We strongly encourage the supervisors (especially the newly-elected supervisor for the 11th District, Kathleen Vincent, who represents Greendale) to vote in favor of this resolution.

Of course, such resolutions, while significant as an expression of disgust, have no substantive effect on the residential segregation which continues to plague Greater Milwaukee, and to create a stark separation between the city and its surrounding suburbs such as Greendale. Addressing this ongoing segregation is the more important, and more challenging, next step. P.A.G.E. stands ready to assist the Village of Greendale and Milwaukee County in working to remedy the current effects of past and present discriminatory practices and other factors which perpetuate segregation. In particular, P.A.G.E., along with other community partners, will work to connect Greendale and the County with the Redress Movement (https://redressmovement.org/), a nationwide effort to address the lasting effects of residential segregation and the resulting unequal distribution of housing, educational, and other resources. We support the Redress Movement's vision of "a society where the damage done through segregation has been addressed and repaired, where what zip code you were born into no longer determines the shape of your life," and we hope that Greendale and the County will join us in remedying the present-day effects of this historical wrong. We look forward to celebrating this resolution's passage by the Board of Supervisors, and to working with you on the next steps.
