A.) This item authorizes the Benefits Division to contract with Health eFx to create and issue 1094 & 1095 tax forms to ensure Milwaukee County is adherence to the Affordable Care Act. Issuance of the form 1094 & 1095s to individuals as required by the ACA will be accomplished by our relationship with Health efx provide consulting and actuarial services to Milwaukee County beginning July 1, 2022 through June 30, 2024.

B.) There is no impact to the current year, other than the time of existing staff. The contract continues existing financial terms, leaving all other terms unchanged, and extends the agreement through June 30, 2024. The proposal includes a market check provision for 2022. Regardless of the difference in terms, the financial impact of the change will be negligible.

C.) There is no impact to the current year. All costs in subsequent years will be reflected in the org.1950 (non-departmental fringe benefits) budgets.

D.) The cost projections for 2023 will increase 6% from the previous year.
