- B. Approval of this item would allocate \$1,538,636 out of Milwaukee County's ARPA award amount of \$183,417,734. Specifically, the funding would be allocated from the \$36.7 million in the Community Support Expenditure Category.
- C. Costs are anticipated to be incurred effective August 1, 2022 and continue until December 31, 2026. Funding for program costs will be disbursed from the County's allocation of ARPA funds to fully offset the costs with no additional impact to the tax levy.
