Subject: From the Executive Director of Parks asking for passive review of a fourth amended scope of work with Cardno Inc. for engineering services, final design and development, and an archeological review of the Little Menomonee River and Parkway which causes the agreement to exceed \$100,000

REQUEST

The Executive Director of Parks is requesting passive review of a professional service agreement with Cardno, Inc. due to a change in scope that requires a fee revision over \$100,000. The original contract was for engineering services and final design development for Little Menomonee River Parkway and the change of scope includes an extended construction monitoring period and implementation of a vegetative monitoring plan to meet DNR and EPA requirements.

POLICY

Implementation of Wisconsin Statutes 59.21(31) with regard to purchase of professional service agreements (under the Milwaukee General ordinance Chapter 56) requires County Board review to award the initial agreement, or fee extension(s) to the original agreement, when the total contractual fee exceeds \$100,000 but is less than \$300,000.

BACKGROUND

In January of 2021 Parks contracted with Cardno, Inc. to complete a habitat management plan and wetland scrape design for the project area known as Sections 4 & 5 of Little Menomonee River Parkway (LMR Parkway), as part of the grant agreement with the Wisconsin Department of Natural Resources. In the prior Amended Work Scope #1 that was approved by the Finance Committee by passive review on March 18, 2021, in County Board file 21-328, Cardno was contracted to conduct an archaeological archival/literature review of Little Menominee River Sections 2 - 6.

In the prior Amended Work Scope #2, that was approved by the Finance Committee by passive review on July 26, 2021, in County Board File 21-648, Cardno was requested to conduct on-site field checks (visual inspection, photo documentation, etc.) of the Little Menominee River Section 2-6 consisting of roughly 5.5 miles and approximately 650 acres as requested by the Wisconsin Department of Natural Resources (WDNR).

In the prior Amended Work Scope #3, that was approved by the Finance Committee by passive review on January 27, 2022, in County Board File 22-305, additional effort was required in order meet the requirements of NHPA Section 106 which required archeological and architectural investigations/evaluations.

The current fourth amended scope of work is required because DNR has extended the construction monitoring period by three months and implementation of a vegetative monitoring plan has been approved and requested of Cardno by the DNR, EPA, and Parks.

Due to the additional work, it is necessary to have a fourth amendment and fee revision to the contract. This increases the contract from \$119,338 to \$144,070.20. An increase of \$24,732.20.
