A RESOLUTION

WHEREAS, the Department of Human Resources (DHR) is requesting to reallocate the pay grade of two, Airport Maintenance Assistant Superintendent positions - Location 504 - Milwaukee Mitchell International Airport (MMIA), Timmerman, Department 5051- 5051 MMIA - Maintenance - General; and

WHEREAS, DHR reviewed the duties of the positions, and compared the classification (compensation) with other similar positions relative to market rates and conditions; and

WHEREAS, the Director of Compensation/Human Resources Information Systems, DHR, recommends that the classification of the pay grade of two, Airport Maintenance Assistant Superintendent positions - Location 504 - MMIA, Timmerman, Department 5051- 5051 MMIA - Maintenance - General; be reallocated; and

WHEREAS, a comparison of the current pay grade and proposed pay grade is as follows:
