AN AMENDED RESOLUTION

Celebrating the civic and design contributions of Frederick Law Olmsted to Washington Park, Milwaukee County, and the United States; renaming the roadway in Washington Park to Olmsted Way; and allocating \$2,000 from Org. Unit 1940-1945 Appropriation for Contingencies to Org. Unit 9010 Parks, Recreation and Culture Administration to update the signage

WHEREAS, the father of American landscape architecture, Frederick Law Olmsted (1822-1903), was a renowned landscape architect, urban planner, conservationist, and **social reformer adherent of the City Beautiful Movement**, who is known for promoting democracy through his designing of urban parks, including Central Park in New York City; and

WHEREAS, Olmsted was a leading abolitionist whose journalism about "The Cotton Kingdom" documented the horrors of slavery in the Antebellum South; and

WHEREAS, Olmsted designed the "Grand Necklace of Parks" in Milwaukee County, including West Park (renamed Washington Park in 1900), Lake Park, Riverside Park, and East Newberry Boulevard, linking Lake and Riverside Parks; and envisioned for Milwaukee's lakefront a "Shore Drive," which became Lincoln Memorial Drive, and a road to connect the lake and the bluff, which became Ravine Road; and

WHEREAS, Olmsted was a contemporary of the leading Milwaukee parks proponent of the 1890s, founding Chairman of the City of Milwaukee Park

Commission father of the Milwaukee County Park System, and namesake for the former Wahl Park, Christian Wahl (1829-1901) (File No. 20-548); and Olmsted inspired future landscape architecture and planning in the United States, influencing the Garden City Movement urban and national parks movements in America; and was an inspiration for Milwaukee County Parks Commissioner Charles B. Whitnall's vision for parks and parkways, and Milwaukee's greenway boulevards; and

Milwaukee County later acquired the renamed Washington Park from the City of Milwaukee in 1937; and

WHEREAS, Washington Park has historically been a multi-use space with facilities constructed for outdoor performances, athletic fields, lawn tennis courts, boating, ice skating, **and formerly** a six-hole golf course, a horse racing track, and a toboggan slide; and

WHEREAS, Washington Park was home to the Milwaukee County Zoo from 1892 to 1958, growing from a small "deer paddock" specified in Olmsted's general plan in 1892, to include a miniature mammal and bird display, to by the turn of the 20<sup>th</sup> Century holding 800 animals on 23 acres, all prior to the construction of the current Milwaukee County Zoo; and

WHEREAS, Washington Park today contains a major senior citizen center, operated by the Department of Health and Human Services, Division on Aging; and

WHEREAS, Milwaukee County adopted File No. 19-227 in April of 2019, which leased certain land and the boathouse at Washington Park to the Urban Ecology Center to increase programming related to education, land conservation and stewardship, and community programs serving the Park and neighborhood; and

WHEREAS, Washington Park is beloved by both residents living nearby and throughout the Milwaukee County community and is an essential part of the "Grand Necklace of Parks" in Milwaukee County, a crucial piece of Frederick Law Olmsted's vision and legacy; and

WHEREAS, April 26, 2022 marked the 200<sup>th</sup> anniversary of Olmsted's birth, Milwaukee County honors Frederick Law Olmsted's contributions to the Milwaukee County Parks System through naming a street in his memory; and

WHEREAS, the Committee on Parks and Culture, at its meeting of July 19, 2022, recommended adoption of File No. 22-769 as amended (vote 5-0); now, therefore,

BE IT RESOLVED, Milwaukee County hereby celebrates 200 years since the birth of Frederick Law Olmsted and honors his legacy and influence in Milwaukee County Parks, and Olmsted's broader civic contributions to American life; and

BE IT FURTHER RESOLVED, the Milwaukee County Board of Supervisors hereby renames the approximate half-mile roadway within Washington Park,

terminating at State Highway 175, also known as the Stadium Freeway, and the intersection West Vliet Street and West Highland Boulevard, as Olmsted Way; and

BE IT FURTHER RESOLVED, the Milwaukee County Board of Supervisors hereby authorizes and directs the Department of Parks, Recreation and Culture to perform any steps necessary to implement the change, including updating signage in and around Washington Park to reflect the new name; and

BE IT FURTHER RESOLVED, the Milwaukee County Board of Supervisors hereby authorizes and directs the Office of the Comptroller and the Department of Administrative Services to process an administrative transfer of \$2,000 from Org. Unit 1940-1945 Appropriation for Contingencies to Org. Unit 9010 – Parks, Recreation and Culture Administration to purchase the supplies and materials necessary to update signage in the Washington Park roadway.
