From the District Attorney, Office of the District Attorney, requesting authorization to create the following positions, in the District Attorney's Office, funded by the American Rescue Plan Act: 5.0 FTE Victim Witness Advocate positions; 1.0 FTE Paralegal position; 4.0 FTE Secretarial Assistant positions; 4.0 FTE Investigator positions; 3.0 Hourly Process Investigator positions; 1.0 FTE Clerical Assistant 1 position; and 1.0 FTE Network Tech Specialist position, by recommending adoption of the following:

## **A RESOLUTION**

 WHEREAS, the State of Wisconsin (the State) announced a plan to send Milwaukee County (the County) much-needed American Rescue Plan Act (ARPA) funds to help the County clear the criminal court backlog in District 1 of the State Court System, decrease recidivism, and increase pretrial services; and

WHEREAS, on March 15, 2022, Governor Evers announced that he was directing an award of \$14,586,230 to the County and its criminal justice system, to address the back log of criminal court cases created by the Coronavirus Disease pandemic; and

WHEREAS, \$5,627,902 was identified for the benefit of the District Attorney's (DA's) Office, for costs related to additional attorney and support staff; and

WHEREAS, of these funds, \$2,966,202.42 will be available for costs related to positions in the County DA's Office; and

WHEREAS, these 19 positions will be vacated and abolished at the time ARPA funding is exhausted by June of 2024; and

WHEREAS, the Committee on Personnel, at its meeting of July 12, 2022, recommended adoption of File No. 22-768 (vote 4-0); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby authorizes and approves the following position actions for the District Attorney's Office, effective the start of the first pay period after approval:
