REQUEST

The Executive Director of Milwaukee County Parks requests authorization to enter into an agreement with Milwaukee Parks Foundation, Inc., to outline roles and responsibilities of the two parties as required by Chapter 13 of the Milwaukee County Code of General Ordinances.

POLICY

Wis. Stat. § 59.52(19) - Donations, gifts and grants. The board may accept donations, gifts or grants for any public governmental purpose within the powers of the county.

Chapter 13 of the Milwaukee County Code of General Ordinances outlines the requirements for agreements with support groups of county departments including allowing support groups to seek funding to support the department.

BACKGROUND

The Milwaukee Parks Foundation, Inc., (the “Foundation”) is a non-profit corporation organized under Chapter 181 of the Wisconsin Statutes with a tax exempt status under section 501(c)(3) of the Internal Revenue Code, and was formed and has functioned for the purpose of soliciting, holding, managing, investing and expending funds and other gifts, grants and bequests

exclusively for the benefit and support of the Milwaukee County Parks, maintained by the County, as well as educational, scientific, and cultural programming.

The Foundation is dedicated to a safe and vibrant parks system that benefits all. Founded by 13 members of the community in December 2019, the Foundation Board of Directors came together to create an outlet for everyone in Milwaukee County and beyond to support the Milwaukee County Parks system, with the belief that these are our parks, this is our community, and this is our future.

Through conversations with county residents and Parks leadership the Foundation developed three major focus areas for grantmaking and fundraising for 2022-2023 including park safety, youth enrichment, and supporting County capital projects.

Per Chapter 13 of the Milwaukee County Code of General Ordinances, Milwaukee County Parks has negotiated an agreement with the Foundation for approval by the County Executive and the County Board of Supervisors.

Per Wisconsin State Statute the County Board may accept donations, gifts, and grants for any public purpose. If a donation has no restrictions the Department may accept it, but if the donation is restricted it requires full County Board approval. For efficiency, Parks Executive Director is requesting the ability to also accept restricted donations from the Foundation that align with the mission of the parks. The monies would still need to be approved and/or recognized through budget adoption, fund transfers, and/or as part of capital projects.

TERMS

- The term of this Agreement is for the calendar year in which it is signed and remains in effect unless and until terminated upon six months written notice by either party
- Includes all requirements under Chapter 13 of the Milwaukee County Code of General Ordinances
- Outlines the relationship between the Foundation and the County
- Includes audit clause and insurance requirements
- Authorizes the Parks Executive Director to accept restricted donations that align with the mission of the Parks
