BACKGROUND

Milwaukee County Parks requests the abolishment of 1.0 FTE Receptionist position in Administration & Planning and creating 1.0 FTE Park Unit Coordinator 2 position in Operations. Additional support is needed in the South Region to differentiate duties within Wilson Park between the Recreation Center, the outdoor activities in Wilson Park, and the Operational responsibilities of other parks in this maintenance unit. This action will also administratively transfer the existing Office Assistant 3 from Wilson in the South Operation Region to Operations administration to assist with customer inquiries, CityWorks, and procurement.

ALIGNMENT TO STRATEGIC PLAN

This item aligns to strategic plan objectives 1A, 2A and 3A. Adding an additional full-time position provides an additional opportunity to hire staff that are reflective of the diverse community, improve on what, where and how services are delivered to advance health equity and provide capacity to invest upstream to address root causes of health disparities.

FISCAL EFFECT

The receptionist position has been vacant for twelve pay periods for a savings of \$19,300 and the proposed creation of a Park Unit Coordinator 2 will be effective for six pay periods at a cost of \$15,370. Milwaukee County Parks has included these position actions in the 2023 departmental request.
