- A. Wisconsin Statutes at Wis. Stat. §§ <u>125.06(6)</u> and <u>125.09(6)</u> enable municipalities and counties to sell "fermented malt beverages" (beer) in public parks, without a license, subject to a local government's enabling ordinance. This resolution advocates for the State of Wisconsin expanding that statute to include all types of alcohol as an expected commodity in parks which enhances local revenue generation in a fiscally constrained environment.
- B. There are no direct costs associated with this resolution. Existing staff time would be needed to communicate the contents of the resolution to State policymakers, the Wisconsin Counties Association, the Wisconsin League of Municipalities, and the Tavern League of Wisconsin.
- C. No budgetary impacts are expected in this or subsequent years. The resolution would not authorize the expenditure of any additional funds.
- D. No assumptions were made.
