 - B. - A. Approval of this resolution will provide a total of \$181,641 in ARPA funds for the Milwaukee Diaper Mission (MDM) project. The MDM program will increase the availability of diaper and period products available to families in need. Funding would allow the MDM program, managed by the Milwaukee Diaper Mission organization, to run from November 1, 2022 until December 31, 2024. The Milwaukee County Department of Health and Human Services (DHHS) will provide contracting, fiscal oversight and project management support to the contractor.
 - B. Approval of this resolution would allocate \$181,641 out of Milwaukee County's ARPA award amount of \$183,417,734. Specifically, the \$181,641 would be allocated from the \$36,739,238 Community Support Expenditure Category.
 - C. Costs are anticipated to be incurred effective November 1, 2022 and continue throughout 2023 and 2024. Funding for the 2022, 2023, and 2024 program costs will be disbursed from the County's allocation of ARPA funds to fully offset the costs with no additional impact to the tax levy. The accompanying resolution authorizes the Office of Strategy, Budget and Performance and the Office of the Comptroller to process an administrative appropriation transfer of \$181,641 to direct funds to DHHS for the Milwaukee Diaper Mission program starting November 1, 2022 until December 31, 2024. This transfer would increase expenditures and revenues to fund 10024, agency 800 and low org 0981.
