A. Authorization to approve a twenty-five-year easement with one ten-year renewal for an underground telecommunication system within Dretzka Park.

B. Revenue of approximately \$15,065 (approximate because it will be based on final lineal feet at a rate of \$5 per lineal foot). The annual revenue will be split equally between the trails and playgrounds trust funds. Staff time will be required for review of the Right of Entry application, but this review time will be compensated by the application fee.

C. The revenue for the easement will be used for trail and playground maintenance and development, which will offset ongoing costs related to the purchase of equipment, maintenance needs, and trail development.
