A. Milwaukee County Parks is requesting authorization to enter into a new lease with the County's current lease partner, Milwaukee Community Sailing Center, Inc., (MCSC) for a term of twenty years with three ten-year renewals. If approved, Parks will execute the lease with MCSC.

B. No costs, savings, or revenues are associated with this request. In lieu of rent, MCSC will continue to provide valuable community opportunities to access Lake Michigan and will continue to maintain the leased premises that solely serves MCSC. Staff time will be used to monitor the lease.
