The Director of the Office of Emergency Management is requesting to enter into a professional services contract with the Medical College of Wisconsin for a contracted Chief Health Policy Advisor. The County has taken on an increased role in health promotion, health equity, and pandemic response as a result of the COVID-19 pandemic and as a result of the County's strategic plan and vision to achieve racial equity and to become the healthiest county in Wisconsin. These roles are expected to continue and a Chief Health Policy Advisor is proposed to be contracted out to take on these responsibilities.
 - B. The cost of this contract is \$113,666.22 for a one year period from August 1, 2022 to July 31, 2023.
 - C. American Rescue Plan Act (ARPA) provides funds for the remainder of 2022. An increase to OEM Directors Office(4812) funding in the 2023 proposed budget provides sufficient funds for 2023.
 - D. The one-year contracted rate for the Chief Health Policy Advisor role is \$113,666.22.
