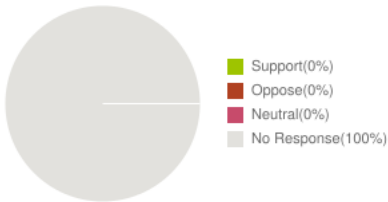

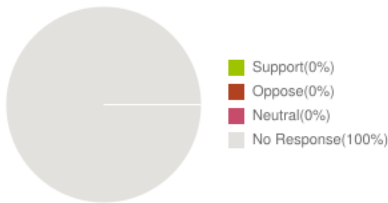

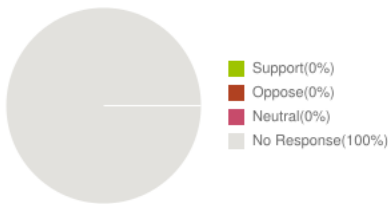

The Comprehensive Sound Study resolution 21-760 and 22-400 indicate the noise AT the Rock Sports Complex would be measured. Presently the noise is not being measured on the property boundary. The compliance of the noise standards per Exhibit C is the Noise Abatement Boundary included the the County Development Agreement Exhibit C Noise and Light Addendum page 5. How will calculations be made to the property line. In addition, has the Sound Study vendor been given access to the existing acoustic equipment in the stadium and umbrella bar. Has an evaluation been made of the speakers pointed out from the facilities which are in conflict with the 2017 Summary of Final Documents and testimony by several county officials that speakers would be oriented away from residential district. That has not been complied with since 2017.
