

15	WITNESSETH

17	In consideration of the mutual covenants herein contained, the parties hereto do hereby
18	mutually agree as follows:

20	PART 1

22	1.01 RECOGNITION
23	The County of Milwaukee agrees to recognize, and herewith does recognize, the
24	Association of Milwaukee County Attorneys as the exclusive collective Bargaining agent
25	of behalf of the employees of Milwaukee County in accordance with the certification of
26	the Wisconsin Employment Relations Commission, as amended, in respect to wages,
27	pursuant to Subchapter IV, Chapter 111.70, Wisconsin Statues.

1	1.02 EMPLOYEE DEFINED
2	Wherever the term "employee" is used in this Agreement, it shall mean and include only
3	those employees of Milwaukee County within the certified bargaining unit represented
4	by the Association.
5	
6	1.03 DURATION OF AGREEMENT
7	This Agreement is to take effect on January 1, 2022. Unless otherwise modified or
8	extended by mutual agreement of the parties, this Agreement shall expire on December
9	31, 2022.

11	PART 2
12	
13	2.01 WAGES
14	Effective Pay Period 8, 2022 (April 3, 2022) the wages of bargaining unit employees
15	shall be increased by two percent (2.0%). Effective Pay Period 18, 2022 (August 21,
16	2022) the wages of bargaining unit employees shall be increased by two percent

(2.0%).
