 - A. Combined Court Related Operations is seeking to abolish 24 vacant Sr. Assistant Clerical positions (4P) and create 22 Specialists Clerical Cts (5P) positions. The creation of the Specialists Clerical Cts positions is being used as a recruitment tool for the department which enables it to fill positions that are capable of working within the CCAP system to eliminate the existing backlog of cases. In addition, the department is looking to recruit and retain new employees at a higher starting pay grade.
 - B. By the department filling the newly created positions at a higher pay grade, we are only seeking to create as many positions as we can to stay within our current tax levy. Therefore, by creating two (2) less positions than we are abolishing, there will be a decrease in salaries.
 - C. Calculating as if the positions were vacant for the entire current year, the action would result in savings of \$12,651.50. For the subsequent year, the action would result in savings of \$12,904.39.
 - D. The mid-point salary was used in this computation. Additionally, social security taxes are included.
