REQUEST

The Milwaukee County Department of Transportation (MCDOT) – Airport Division is requesting an extension of Jennifer Rittberg's Temporary Assignment to a Higher Classification (TAHC) to the position of Accounting Supervisor through June 24, 2023, or until the position is filled permanently.

The request is being made to provide necessary coverage of financial supervisory roles during the recruitment process for the permanent filling of the Airport Accounting Supervisor position. Due to broader staffing and recruitment challenges, Ms. Rittberg continues to also perform her normal duties of Airport Senior Analyst for Budget and Management.

POLICY

Chapter 17.085 of the Milwaukee County Code of General Ordinance requires an extension of temporary assignment beyond 180 days to be approved by the Milwaukee County Board of Supervisors.

BACKGROUND

The Department of Transportation – Airport Division Finance Section has experienced substantial turnover from late 2021 and continuing into 2022, primarily due to compensation issues.

These departures have left Airport Finance with multiple vacancies. The Airport is continuing to actively work to fill these positions but, in the meantime, there is a need for continuity in critical supervisory positions such as the Accounting Supervisor roles.

This TAHC extension request will not have any effect on the financials of Milwaukee County including no effect on the property tax levy.
