POLICY

This request is being made pursuant to File 22-662, "To modify Chapter 106 of the Milwaukee County Code of General Ordinances to reestablish the Milwaukee County Commission on Youth and align its priorities with Milwaukee County's mission and vision to achieve racial equity..." in which the following process was established:

"(2) Selection committee. Upon adoption of this ordinance, an initial selection committee shall be created to select the first youth commissioners. The initial selection committee will consist of two adults and three youth (age 18 or under) who will be jointly appointed by the county executive and the county board chairperson. The initial selection committee shall review all applications by utilizing published criteria and interview prospective commissioners. The initial selection committee shall submit the names of the first commissioners to the county board for confirmation." [emphasis added]

BACKGROUND

The resolution to re-establish the Milwaukee County Youth Commission was authored by Chairwoman Nicholson and County Executive David Crowley and co-sponsored by Supervisors Sequanna Taylor, Martin, Clancy, Vincent, and Burgelis. It was passed unanimously by both the Committee on Intergovernmental Relations and the Board of Supervisors in May of 2022.

The application period for the 2023-24 term opened on September 1 and closed on September 30, 2022. The implementation team directly recruited from 83 high schools and youth-serving organizations in Milwaukee County. Seventy-five applications were received, and 28 applicants participated in one of three group interview options (two virtual and one in-person). The Chairwoman and County Executive jointly appointed two adults and two youth to serve on the Initial Selection Committee (ISC), which developed and utilized an objective rubric to score the applications and group interviews.

In addition to the 18 youth commissioners that were selected by the ISC, the two

Commission Co-Chair appointments by Chairwoman Nicholson and County Executive Crowley have been submitted as separate files.

ALIGNMENT TO STRATEGIC PLAN

The Milwaukee County Youth Commission aligns with the following Milwaukee County strategic objectives:

- 1A: Reflect the full diversity of the County at every level of County government The Youth Commission will increase the diversity of age and life experience at the highest level of Milwaukee County government, providing a valuable perspective that is currently missing from decision-making processes.
- 1B: Create and nurture an inclusive culture across County government

 The Youth Commission will help to make our legislative process more inclusive,
 especially since young people under the age of 18 are not allowed to participate in the
 voting process to choose our elected leaders.
- 3C: Dismantle barriers to diverse and inclusive communities

 The Youth Commission embodies the diversity of Milwaukee County, bringing together young people who will represent their respective districts, but will get to learn from and interact with their peers from other areas.

FISCAL EFFECT

Costs associated with the implementation of the Milwaukee Youth Commission have been approved for the current budget year and an additional request is included in the County's Executive's 2023 Proposed Budget.
