- A.) This item authorizes the Benefits Division to extend contracts with United Health Care and Optum Rx to provide administrative Medical and Pharmacy services and the voluntary fully-insured Medicare Advantage option through the 2025 plan year.
- B.) There is no impact to the current year, other than the time of existing staff. The contract extension modifies existing financial terms, leaving all other terms unchanged, and extends the agreements through 2025. The proposal includes a market check provision for 2022. Fully-insured Medicare Advantage rates are subject to a rate renewal on an annual basis. That would be a separate agreement.
- C.) There is no impact to the current year. All costs in subsequent years will be reflected in the org.1950 (non-departmental fringe benefits) budgets.
- D.) The savings projection was developed by Willis Towers Watson's actuaries, and were subsequently vetted by the Benefits Division. Pharmacy savings are derived by applying the proposed terms to the current enrollment and utilization. Changes to enrollment or utilization will cause a change to savings (positive or negative).
