  - A. Approval of this request will authorize the DAS-FMD to execute a Service Contract for Countywide janitorial services with UG2, LLC, for a base term of three years.
  - B. The total value of the 3-year base term of the contract will be \$16,966,138. Costs will be borne by the Departments directly receiving the services, including DAS, MCDOT, Parks and Sheriff. Should County decide to extend the contract by its two additional option years, the total projected value of the 5-year contract is \$29,454,162.
