A. The Director of the Department of Health and Human Services (DHHS) is requesting authorization to execute 2023 Housing Services purchase of service contracts with community vendors.

Approval of this request will allow the Director of DHHS to execute purchase of service contracts to continue provision of contracted Emergency Shelter Care, Permanent Supportive Housing Development Support Services, Supported Apartments, Shelter Plus Care Supportive Services, Peer Support Program, and Homeless Case Management for the period January 1, 2023 through December 31, 2023.

B. Total 2023 expenditures included in this request are \$4,567,129.

C. There is no tax levy impact associated with approval of this request in 2023 as funds sufficient to cover associated expenditures are included as part of Housing's 2023 Budget.

D. This fiscal note assumes expenditures will not exceed the amounts authorized for these purchase of service contracts.
