| 17 18 19 20 | WHEREAS, one of the largest revenue sources for the Department of Health and Human Services (DHHS) are State and Federal funds, that are forwarded to DHHS, under Community Aids, which funds programs in Aging and Disabilities Services, Housing Services, and Behavioral Health Services; and |
| 21 22 23 24 25 | WHEREAS, the 2023 Community Aids contract for DHHS provides an allocation totaling \$17,127,720, and this amount is \$32,471 higher than the 2023 total revenue amount of \$17,095,249, included in the DHHS 2023 Adopted Budget; and |
| 26 27 28 | WHEREAS, similar to previous years, this contract requires a County match of \$3,565,149, which is included in the 2023 Adopted Budget; and |
| 29 30 31 | WHEREAS, it is in the County's best interest to execute contracts in a timely manner, to improve cash flow, and maximize interest earnings; and |
| 32 33 34 35 | WHEREAS, the County will not receive any State Community Aids revenue until the Milwaukee County Board of Supervisors has authorized the Director, DHHS, to execute the contract; and |
| 36 37 38 | WHEREAS, the Committee on Finance, at its meeting of December 8, 2022, recommended adoption of File No. 22-1119 (vote 6-0); now, therefore, |

39 BE IT RESOLVED, the Director, Department of Health and Human Services 40 (DHHS), or her designee, is hereby authorized to enter into a contract (and any 41 addendum thereto), with the State of Wisconsin (the State) Department of Health 42 Services, covering Social Services and Community Programs (Community Aids), for the 43 period January 1, 2023, through December 31, 2023, in the amount of \$17,127,720; 44 and 45

46 BE IT FURTHER RESOLVED, of the \$17,127,720 in State Community Aids 47 revenue, \$5,381,228 is Basic County Allocation funding, and \$11,746,492 is for 48 earmarked revenues, to support programs and services within DHHS, as identified on 49 the attachment included in this file; and

51 BE IT FURTHER RESOLVED, the Milwaukee County Board of Supervisors 52 authorizes a Milwaukee County match of \$3,565,149, which is required under the 2023 53 State contract for Community Aids and is included in the 2023 Adopted Budget.
