19 20 21 22 23 24	WHEREAS, in March 2022, the Procurement Division, Department of Administrative Services (DAS), in partnership with the Facilities Management Division (FMD), DAS, the Department of Transportation, the Office of the Sheriff, and Department of Parks, Recreation, and Culture, developed and launched an RFP for a new Contract; and
