REQUEST

From the Executive Director of Milwaukee of County Parks, requesting authorization to approve a request by the South Milwaukee School District (SMSD) to renovate a baseball diamond on Oak Creek Parkway that it currently leases from Milwaukee County.

POLICY

Per Section 32 of the 2002 Lease Agreement, if SMSD wishes to construct any new improvements upon the Leased Premises it must obtain approval from the Milwaukee County Board of Supervisors and the County Executive.

BACKGROUND

Milwaukee County Parks (Parks) and SMSD have partnered since 1993, for mutually beneficial use of a baseball diamond on Oak Creek Parkway near South Milwaukee High School and additional lands including Rawson Woods. The current lease commenced on February 1, 2002, and recently renewed for another twenty years with the current term ending in 2042 (File No. 22-134).

Per Section 32 of the 2002 Lease Agreement, if SMSD wishes to construct any new improvements on upon the Leased Premises it must obtain approval from the Milwaukee County Board of Supervisors and the County Executive and all plans must be reviewed and approved by the Parks Department.

SMSD has requested to make improvements to the baseball diamond within the Leased

Premises, including a Synthetic Turf infield. The construction of a synthetic turf infield requires an underdrain system and installation of a new stormwater sewer line, which approval falls within the purview of the County Board and County Executive per the 2002 Lease Agreement.

Parks has done a preliminary review of the plans and is in favor of the improvements, pending final review of all plans, including stormwater plans, which shall be done through the Right of Entry process.
