# **REQUEST**

The Office of Strategy, Budget and Performance recommends approval of \$11,456,094 in Opioid Settlement fund allocations for 15 proposals aimed at addressing the opioid crisis in Milwaukee County for fiscal years 2023, 2024, and 2025.

### **POLICY**

The County Board authorized the Office of Corporation Counsel (OCC) to retain outside counsel under a contingency fee arrangement and to file suit against opioid manufacturers and distributors as the OCC deemed appropriate in File 17-722.

2021 State Act 57 created Section 165.12, Wisconsin State Statutes (State Statutes), relating to the settlement of all or part of the Litigation. Section 165.12(4)(b)2, State Statutes, provides the proceeds from the Settlement Agreement must be deposited in a segregated account (the Opioid Abatement Account), and may be expended only for approved uses for opioid abatement, as provided in the Settlement Agreements.

On December 15, 2021, the Milwaukee County Board approved Resolution <u>21-1127</u> which authorized Milwaukee County Office of Corporation Counsel (OCC) to enter into Settlement Agreements to receive funds from three Opioid Settlement distributors.

## **BACKGROUND**

Milwaukee County has among the highest rates of overdose deaths in Wisconsin, and record numbers of emergency calls related to overdoses have been seen in the last two years. From 2014-2020, the opioid overdose fatality rate in Milwaukee County was 30.9 per 100,000 persons, more than twice the Wisconsin rate of 14.8 per 100,000.

Wisconsin will receive \$420 million which will be divided between 87 local governments. Milwaukee County's portion of those funds total approximately \$71 million. After attorney fees, Milwaukee County will receive \$56.6 million over 18 years.

The Comptroller's Office projects that Milwaukee County will receive approximately \$19.1M in Opioid Settlement funding through 2025 based on a disbursement schedule provided by advisors. The office continues to monitor <a href="https://nationalopioidsettlement.com">https://nationalopioidsettlement.com</a> to track progress of payments on a national basis.

Approved County Board Resolution 21-1127 called for the establishment of a segregated Opioid Abatement Account that is not part of the general fund. Any unused funds that remain at the end of the year will be carried over to the new year.

## Allocation Process

Milwaukee Count gathered input from County stakeholders and facilitated a process to make allocation recommendations for the Opioid Settlement Funds. This process was presented to Supervisors during the December board cycle in File 22-1135.

**Proposal Phase (October 2022):** County service areas proposed projects that include one-time equipment, technology or capital items or programmatic expenses for up to three years. The proposal window will be replicated annually based on fund availability from current and future settlements.

Review Phase (November-December 2022): An eight-person review panel was established and composed of six community members and stakeholders (75%) and two County content experts (25%). The panel reviewed proposals based on predetermined criterion and deliberated to make subject matter, equity-based spending recommendations that maximize the positive impact of opioid settlement funds in Milwaukee County.

Approval Phase (January-February 2023): The Milwaukee County Board of Supervisors is being presented with a request for fund authorization for 15 recommended projects totaling \$11,456,094. Implementation will launch shortly thereafter.

Milwaukee County gathered local, statewide, and program specific input from community members, stakeholders and front-line staff in the development of initial Opioid Settlement Fund project investments. Milwaukee County departments pursue community engaging activities on an ongoing basis, complimenting the availability of Opioid Settlement Funds. Attachment B outlines the various modes of input considered in the development of the project recommendations.

### Review Panel Recommendation

The Opioid Settlement Review Panel recommends approval of \$11,456,094 in Opioid

Settlement funds for 15 proposals aimed at addressing the opioid crisis in Milwaukee County for fiscal years 2023, 2024, and 2025. A summary of those proposals is provided below.



# **ALIGNMENT TO STRATEGIC PLAN**

The County seeks proposals that aim to address the opioid crisis utilizing multiple, innovative strategies including treatment, harm reduction,

prevention and other strategies. Further, proposals must address one of the funding objectives derived from statewide listening sessions and recommendations from the City/County Opioid Heroin Task Force.

# **FISCAL EFFECT**

Approval of this action will provide a total of \$11,456,094 in Opioid Settlement Funds to 15 projects for fiscal years 2023, 2024, 2025 in the departments of Health and Human Services, Office of Emergency Management, Medical Examiner's Office and the Sheriff's Department.
