ARPA funding to reduce the ongoing risk of COVID-19

The Office of Strategy, Budget, and Performance requests \$2 million in American Rescue Plan Act (ARPA) funding to allocate for internal efforts to reduce the ongoing risk of COVID-19 to employees and the people we serve in Milwaukee County facilities.

POLICY

Milwaukee County Board file 21-555: "A resolution to create a Task Force to review and recommend funding allocations to the Milwaukee County Board of Supervisors for monies received by the County in the Federal American Rescue Plan Act of 2021"

BACKGROUND

Milwaukee County directly received \$183 million in federal ARPA State and Local Fiscal Recovery Funds to spend through December 31, 2026. On September 2, 2021, the ARPA Task Force approved ARPA Expenditure Categories and a process for reviewing and recommending ARPA funding allocations. Within this process, the COVID-19 Mitigation subgroup was established to make recommendations to use ARPA funds to efficiently manage communication and mitigation efforts in response to fluctuations in local data.

Since December 2022, the subgroup has reviewed 24 requests for COVID-19 mitigation funds and approved \$2,157,045 in expenses of the \$2,500,000 COVID-19 Mitigation allocation approved by the Milwaukee County Board of Supervisors. The COVID-19 Mitigation funds are requested by department and office leads to purchase personal protective equipment, testing, physical changes to facilities, and other mitigation efforts. Focusing on internal COVID-19 mitigation improves the County's ability to proactively prepare the county to continue providing services throughout the ongoing pandemic and to stabilize staff needed for pandemic responses in County service areas. The \$2 million in ARPA funding will ensure that there is continuity of funding for COVID-19 response activities when the allocation of \$2,500,000 is fully expended.
