- A. The Office of the Comptroller is requesting approval of the attached initial authorizing resolution of a not-to-exceed amount of \$210,350,000. The resolution also authorizes the reimbursement of expenses related to projects that occurs prior to the issuance of the bonds/notes.
- B. The estimated debt service costs for the not-to-exceed amount of \$210,350,000 of Corporate Purpose Bonds/Notes is \$299,148,000 which includes \$88,798,000 of interest costs.
- C. The bonds and notes issued in 2023 will not impact the 2023 operating expenses. It is anticipated that the first principal and interest payments will occur in 2024. The estimated debt service expenses for 2024 from the bonds and notes issued in 2023 is approximately \$8,312,000.
- D. The total estimated debt service associated with the total not-to-exceed amount of \$210,350,000 is based on seven individual debt schedules and includes an inflationary factor. The combined schedule includes a 15-year financing schedule of \$78,685,000 for the Forensic Science Center project, a 15-year financing schedule of approximately \$45,920,000 for the new Milwaukee Public Museum Building, a 15-year financing schedule of approximately \$27,290,000 for general projects, a 10-year taxable note financing schedule of \$26,065,000 to finance potential private activity projects, a 15-year financing schedule of \$15,310,000 for the replacement of the North Shop, a 4-year financing schedule of \$7,350,000 for fleet equipment replacements and a 5-year financing schedule of \$3,720,000 for Transit Notes. A more refined estimate will be provided when the Parameters Resolutions are submitted to the Finance Committee for approval.

The not-to-exceed debt service schedules also include costs of issuance. The estimated cost of issuance reflects the 2 percent maximum allowable amount. It is anticipated that the financing for the Forensic Science Center and the new Milwaukee Public Museum Building will occur in 2024. The coupons for the 2023 issues are anticipated to be 5.0-5.5 percent. The coupon for the 2024 issue are anticipated to be 6.0 percent. The actual interest rates will be based on market rates on the day of the sale and premiums that may be received.
